Nominations / Applications are invited for the post of Director on deputation (including short term contract / absorption), Centre for DNA Fingerprinting and Diagnostics (CDFD), Hyderabad, an autonomous institute under the Department of Biotechnology, Government of India, from Indian citizens including those staying abroad and Non-Resident Indians (NRIs).

The Centre uniquely combines two kinds of activities, the first being those of services in the twin areas of DNA profiling for law-enforcement agencies and diagnostics tests and clinical counselling for genetic disorders, and the second that of cutting-edge basic research in various disciplines of modern biology, in such a way that each supports and in turn is enriched by the other.

The applicants should be below 58 years of age. The post carries in Level – 15 of Pay Matrix of 7th CPC with usual allowances as per Govt. of India Rules.

The applicants should be Scientists from Central / State Governments, Research Institutes, Autonomous Bodies, Government funded Research organizations / Institutes etc.

(i) Holding analogous post on regular basis in the parent Department.

or

(ii) 3 years service in post with Pay Matrix Level – 14 or equivalent in the parent cadre / Department and possess the qualification & experience as below:-

Essential:

- (i) Ph. D in any life science discipline / M.D. or equivalent
- (ii) Minimum 15 years experience of research in the area of organismal, cellular, molecular or systems biology, or biotechnology.
- (iii) Excellent track record, hand in publications, patents and awards.

Desirable:

- (i) Experience in successfully running large programme, centre, institution
- (ii) Experience of guiding research activities in the area of specialization.
