I am directed to say that the matter for maintaining the uniformity in Bye-laws of all the Autonomous Institutes (AIs) was under consideration in the Department. The Hon'ble Minister for Science and Technology has approved the following:-

- (i) In case of recruitments made by an officiating Director/Executive Director/Chief Executive Officer of the Autonomous Institutes (AIs), the same shall be reviewed by the Chairperson of the Governing Body/Governing Council of such AI after having been examined by Joint Secretary (Administration) and Financial Advisor in the Department of Biotechnology (DBT).
- All Governing Bodies and Governing Councils of AIs shall, henceforth, be named (ii) only as Governing Body. Also it needs to be ensured that the composition of the Societies, Finance Committee (FC) and Scientific Advisory Committee (SAC) of Als follow a uniform pattern.
- The four bodies viz. Society, Governing Body, Finance Committee and Scientific (iii) Advisory Committee in each of the AIs shall have the following composition, namely:

- (iv) The proposal for all nominations to be made by President of the Society of all AIs should be put up by Secretary, Department of Biotechnology latest by 30th April of each year or within a fortnight of the vacancy as and when it occurs.
- (v) The promotion of Technical Cadre is being looked after in detail by Dr. Goel Committee, and hence the promotion of Technical Cadre under MANAS are deferred till further orders.

(vi) It was observed that some of the AIs have different provisions in the RRs (under Clause 4 of RRs) wherein residency period of 100-50% or 50% spent on contract are counted for confirmation and promotion. In order to maintain uniformity among all AIs under DBT, the Hon'ble Minister for Science & Technology has approved the following:-

"All the appointments on regular positions be done on PROBATION. Full period on probation will be counted towards promotion etc. The initial period of probation will be 02 years that can be extendable by another 01 year."

- 2. The Hon'ble Minister for Science & Technology has desired that suitable action may be taken by DBT and all AIs to give effect to these directions. All Bye-Laws stand amended to this extent.
- 3. The Registrar of Societies and/or all competent authorities be apprises about these changes as and where required after due modification of relevant documents within next five working days.
- 4. All AIs are therefore, requested to incorporate the above provisions in their Memorandum of Association (MoA), Bye-laws and Recruitment Rules (RRs) under intimation to this Department.
- 5. For fresh composition of current committees, names of ex-officio members and suitable names to be included in panel for nominated members, to be sent to Hon'ble Minister be sent along with a short CV within next ten days. The compliance report may also be submitted to this Department by 15.10.2020 positively.

A scheme to utilize the expertise of retired scientists who had made outstanding scientific / research contribution in Science & Technology has been approved for implementation in Departments / Ministries and their constituent institutions and laboratories under the Ministry of Science and Technology and Ministry of Earth Sciences. The scheme offers two types of positions, namely, Distinguished Professor / Scientist and Chair Professor / Scientist to retired scientists. The Scheme is open to eligible professors / scientists retired or nearing retirement in National research labs / institutes / Departments and academic institutions including the Laboratories / Institutes / Headquarters of the concerned Ministry / Department / Agency.

- The details of the scheme including remuneration and other entitlements, minimum eligibility and responsibility, tenure, method of selection and other guidelines are given in Annexure.
- The scheme would be implemented in Departments / Ministries and their constituent institutions and laboratories under the Ministry of Science and Technology and Ministry of Earth Sciences. This may be used as guidelines by other Ministries / Departments / Agencies as per their requirements and may adopt following their due processes of appraisal and approval mechanisms.
- Ministry of Science and Technology & Ministry of Earth Sciences and their Departments, 4. Institutes and Laboratories should ensure that all existing schemes of similar purpose for retired scientists should be brought within the ambit of the present scheme, immediately.
- This issues with the approval of the Hon'ble Union Minister for Science & Technology, Earth Sciences and Health & Family Welfare vide E-Office No. E 26931 dated 12.06.2020 & 04.09.2020.

1. The Scheme

The scheme inducts retired scientists in two streams, one based on skill sets (inhouse) and other on knowledge, which flows into the system from outside.

2. Positions

- (i) The Scheme offers two types of positions, namely, Distinguished Professor / Scientist and Chair Professor / Scientist to retired scientists. The Department / Agency name may be prefixed with the position.
- (ii) Scientists retired in the pay level 15 and above (HAG & above) are eligible for Distinguished Professor / Scientist whereas scientists retired in the pay level 13A and above (Scientist F & above) are eligible for Chair Professor / Scientist.

3. Number of positions

Each Department / Agency should assess their requirement of number of positions keeping the interests of the institution first and not that of the retired individual. The positions should not be part of the sanctioned manpower of the Department / Agency. Budget provision shall be made through due allocation of the Department / Agency year to year. As a general rule, the following principle should be followed:

- (i) The number of positions should be limited to 25% of the total number of Scientists who have retired from the Ministry / Department and their constituent laboratories / institutes. Scientists who are at the rank of Scientist 'F' or above at the time of retirement are taken into account for arriving at the total number of retired scientists. The decimal numbers, if any are to be rounded off to the next larger whole number. To begin with, the total number of scientists who have retired in the last three years may be considered for deciding the number of positions to be made available in 2 levels, namely, Distinguished Professor/ Scientist and Chair Professor/ Scientist. A uniform cut-off date proceeding three years from 01.07.2020 may be taken for this purpose. Further on, the number of scientists retired between two consecutive selection events would be taken into account for arriving at the number of positions. Within the overall number, the Minister, concerned shall decide the number of positions in each level.
- (ii) Not less than one-third of the positions will be awarded to scientists who do not belong to the Department or constituent laboratories concerned. However, in exceptional cases, this can be relaxed purely based on scientific merits such as non-existence of specialized knowledge outside the Dept./Lab. In such cases 100% positions can be offered to retired scientists from within the Department or constituent laboratories. Secretary of the concerned Department shall decide such relaxation.



4. Remuneration and other entitlements, Minimum Eligibility and Responsibility

The monthly remuneration shall be payable on lump sum basis without any allowances other than the Travel Allowance. The list of categories and other entitlements admissible to them shall be as under: -

5. Tenure: The initial tenure of the incumbents under the scheme shall be for a period of three years, renewable every year based on the fulfilment of quantifiable deliverables as per the terms and conditions of appointment. The term of Distinguished Professor / Scientist & Chair Professor / Scientist shall be extendable only by two additional years after review. The maximum tenure in no circumstances shall exceed 5 years including broken periods, if any.

6. Method of Selection

(i) Stream I for in-house retirees: The Director / Head of the Institution shall send his/her nomination to the Department / Ministry concerned. In case of retiring Directors / Head of the Institutions to be considered, the Secretary of the Department / Ministry may nominate him/her for consideration in the same institution or outside within the Ministry / Department.

Stream II for bringing outside knowledge into the system: The Department / Ministry should give an open advertisement to seek applications. These calls need not to be given yearly. It is to be ensured that one-third of the positions are to be filled over a period of 5 years.

(ii) A Screening Committee of the following composition shall be constituted by the concerned Department/Agency for selection, after approval by the Union Minister concerned:

Three subject experts - Members

Autonomous Institutions of the concerned Department



Drawal of Pension: A retired employee, who is conferred with any of the above positions, shall continue to draw pension and the dearness relief on pension during the tenure of Distinguished Professor / Scientist or Chair Professor / Scientist as per one's entitlement and regulated as per the Pension Rules. His / her engagement to any of the above positions shall not be considered as a case of re-employment.



8. Allowances: The individuals engaged under the Scheme shall not be entitled for payment of any kind of allowances such as Dearness Allowance, House Rent Allowance, Government Accommodation, Medical Reimbursement, Telephone/Broadband reimbursement etc. except for Transport Allowance as described:

Distinguished Professor / Scientist and Chair Professor / Scientist shall be entitled to draw Transport Allowance at the rate of Rs. 15,750 pm. The allowance will not be admissible for the calendar month(s) wholly covered by leave. They would not be provided any other mode of transport facility.

- 9. Travel Entitlement: The travel entitlement will be regulated as per entitlement at the time of their retirement under the rules. TA/DA shall also be paid as per their entitlement at the time of their retirement under the rules and in accordance with the government guidelines issued from time to time. The travel on work for the concerned Department / Agency shall only be considered on duty.
- Travel Abroad: The travel assistance would not cover any international travel. The foreign visit of Distinguished Professor/ Scientist and Chair Professor/ Scientist, on the third party sponsorship (partial/full), which is not relevant to the concerned Department, shall be approved by Secretary on the recommendation of the concerned Director / Head of the Institution. And likewise, for private visit abroad (at own expense), prior permission of the Secretary based on the recommendation of the Institute Director / Head shall be necessary. In both cases, the period of absence shall be adjusted and regulated against the leave due. There shall be option to either debiting of remuneration or debiting of entitled leave during the absence.
- 11. Extension: The incumbent will submit a request for extension elaborating the work done in the intervening period with emphasis on notable achievements made, if any. A Committee comprised of a Senior most scientist in the Department and two external subject experts consider the request for extension. The evaluation report of the Committee along with recommendation of the Secretary of shall be put up to Minister concerned for approval of extension.
- **12. Nature of support**: In addition to remuneration as specified at section 4, the Distinguished Professor / Scientist and Chair Professor / Scientist will be supported with a research / contingency grant of Rs. 5.0 lakh per annum.
- 13. Leave: The incumbent shall attend the office for not less than 200 working days of the lab/establishment to which they are reporting. They shall be entitled to leave of absence of 30 days in a calendar year akin to Earned Leave. The leave may be availed with the sanction of concerned Director / Head of the Institute. For tenure less than a year, the period shall be adjusted on pro-rata basis. The grant of leave beyond these limits and only under exceptional circumstances shall be at the discretion of Minister of the Department concerned. No leave shall be



accumulated, and no remuneration shall be awarded during such leaves, however the period shall be counted towards total tenure.

Appointing Authority 14.

Secretary of the Department / Ministry appoints the Distinguished Professor / Scientist, and Chair Professor / Scientist with the approval of the Minister concerned.

Tenure Extending Authority 15.

Secretary of the Department / Ministry extends the tenure of the Distinguished Professor / Scientist, and Chair Professor / Scientist with the approval of the Minister concerned.

General Guidelines 16.

- Distinguished Professor / Scientist and Chair Professor / Scientist are eligible to (i) be posted and work in any of the Indian Institutions including the Laboratories / Headquarters of the concerned Department / Agency.
- The role of the incumbents shall be limited to the core scientific and technical (ii) activities of the concerned Department. They may be enabled with necessary infrastructural support including internet, access to Library, etc., to carry out the assignments.
- They shall take part in technical and scientific reviews in the capacity as (iii) Chairman, Member or Invitee.
- They shall not be assigned with any functional designations like Deputy Director, Group Director, Division Head, Project Director, Deputy Project Director, Chief General Manager, General Manager.
- They shall not be vested with any administrative powers such as leave (V) sanctioning, tour approval, APAR assessment (Reporting, Reviewing & Countersigning), approval for forwarding of any administrative matter.
- (vi) They shall not exercise any financial powers including those specified in the purchase and stores procedures.
- (vii) The individual should not be receiving any other honorarium/ fellowship from any Government sources like J.C Bose Fellowship, National Science Chair etc. while holding the position of Distinguished Professor / Scientist or Chair Professor / Scientist.
- (viii) The individual shall not be allowed to hold any regular position with any private company or government organization while holding the position.



- (ix) The office support and other infrastructural facilities viz; telephone, broadband, computer shall be provided by the concerned Lab/Establishment/Unit.
- For participating in seminars/symposia/conferences/workshops, meetings/talks in non-Departmental capacity within India, the incumbents shall obtain prior consent (x)of Secretary. They may avail a 15 days' period in a year for attending government (out-of-Departmental) commitments with an option to either debiting of remuneration or debiting of entitled leave during the absence. This is an annual ceiling and would not be carried forward. No expenditure for the aforesaid purposes shall be borne by Department including travel, TA/DA and conference fee etc. However, they can take avail the hospitality/TA/DA from the sponsoring agency.
- (xi) They shall not be authorized for honorarium in lieu of his / her participation in any committee of the concerned Department.
- (xii) The service of Distinguished Professor/ Scientist and Chair Professor/ Scientist may be terminated at any time during the tenure by Minister concerned, without assigning any reasons. The notice period of one month shall be given in such termination. They can also resign with the prior notice of one month. The payment of one month's remuneration in lieu of notice period by either side or if shorter notice than one month, the remuneration shall be paid on the prorata basis.
- (xiii) Offer of appointment shall be issued by Ministry / Department giving the details of scope of work, qualitative and quantifiable deliverables, administrative controls, place of work, remuneration etc.
- (xiv) They shall submit the following technical reports of the work carried out by them during the tenure.
 - a. Self-attested Yearly Plan of technical deliverables/milestones envisaged for the current year at the beginning of tenure and at the commencement of every fellowship year on renewal of the tenure.
 - b. Self-attested Half-Yearly Progress Report of milestones achieved, attendance details, leave availed etc.
 - c. Annual Report in details on technical work carried out vis-a-vis quantifiable deliverables projected in the original proposal/tenure at the end of every year.
- (xv) In respect of Distinguished Professor/ Scientist and Chair Professor/ Scientist (or similarly designated) presently serving in any of the Departments under Ministry of Science & Technology and Ministry of Earth Sciences or its constituent institutions and laboratories, there engagement/contract shall cease to exist on the date of completion of their present tenure, and no further extension of term/tenure shall be considered, other than the procedure prescribed in the OM.



(xvi) Any subject matter not covered in the guidelines, shall be referred to DST for clarification, and if entails financial outgo, shall only be proceeded with prior consultation with IFD, DST.

I am directed to refer this Department's letter No.AID-25021/2/2020-AIPSU-DBT dated 12.10.2020 on the above mentioned subject. The para 1 (v) of the referred letter dated 12.10.2020 mentioned that the promotion of Technical Cadre is being looked after in detail by Dr. Goel Committee, and hence the promotion of Technical Cadre under MANAS are deferred till further orders.

- 2. There were many representation received from the various Autonomous Institutes (AIs) under DBT with request to permit to consider the cases of technical staff for promotion under MANAS till the finalization of the new policy by Dr. Goel Committee i.e. UCPS since some of their employees have completed residency period required for considering promotion under MANAS.
- 3. The matter has been considered in the Department and it has been decided with the approval of the Hon'ble Minister of State (I/C) for Science & Technology and Earth Sciences for continuation/implementation of promotion of Technical Cadre under Merit and Normal Assessment Scheme (MANAS) in all Autonomous Institutes under DBT wherever-MANAS is applicable under the current approved scheme as per their Approved RRs till the approval of recommendations of Dr. Goel Committee Report i.e. Uniform Career Progression Scheme (UCPS).
